Norwatt maintains its firm commitment to the conservation, respect, and protection of the environment, as established in our Environmental Policy available in the certificates section of our website. During 2024, we have continued strengthening our Environmental Management System, ensuring compliance with applicable legal requirements and promoting continuous improvements in our environmental performance.

1. Incorporation of Renewable Energies

In line with our sustainability strategy, in 2024 we have expanded our offer of energy solutions by integrating emerging renewable energy technologies. This includes the implementation of energy storage systems using lithium-ion batteries and the provision of inverters for photovoltaic installations, both in grid-connected and standalone configurations.

2. Collaboration with Sustainable Suppliers

We continue to work with European manufacturers who follow strict environmental and quality guidelines. For example, our supplier Saft launched the "Net Zero" program, a comprehensive initiative aiming to achieve net-zero emissions by 2050. This program is based on five fundamental pillars:

- Reduction of environmental footprint.
- Support to customers in reducing their environmental footprint.
- Sustainable use of resources and circular economy.
- Selection of responsible suppliers.
- Regulatory compliance and best practices.

Additionally, we collaborate with Exide Technologies, a leading company in energy storage solutions, which has closed-loop battery recycling systems and active circular economy programs. Exide operates under ISO 14001 certifications and develops low-carbon emission production processes, reinforcing our shared commitment to sustainability. At Norwatt, we are committed to establishing long-lasting relationships with suppliers who share our environmental values and standards. We regularly evaluate their environmental policies and performance, encouraging continuous improvement and alignment with our strategic sustainability objectives.

3. Efficiency in Internal Processes

We have achieved further reductions in energy and paper consumption in our offices, despite having a small team. These improvements reflect our ongoing commitment to efficiency and sustainability in our daily operations.

4. Legal Compliance and Audits

In 2024, we successfully passed external audits conducted by AENOR, demonstrating our compliance with legal requirements and other commitments applicable to our activity. These audits have also validated the effectiveness of our Environmental Management System and the improvements implemented during the year.

5. Objectives for 2025

Looking ahead to next year, we aim to:

- Expand the integration of renewable energy technologies in our projects.
- Strengthen collaboration with suppliers demonstrating a strong commitment to sustainability.
